R.C.voice Character Usage Guidelines

This Guidelines ("Guidelines") establishes the terms and conditions regarding usage of the Characters (as defined below) of the Products (as defined below) provided by CRIMSON TECHNOLOGY, Inc. ("CRIMSON") and usage of the Characters' Converted Voice ("Converted Voice").

Section 1. Definition

- (1) "Product" means the application software "Voidol" (including any related upgraded versions, modified versions, etc.) provided by Voidol.
- (2) "Voice Conversion Model" means voice analysis data for each Character referred to convert voice.
- (3) "Characters" are abstract concepts in which the appearance features are expressed by the work such as an illustration or image displayed on screen by the Product.
- (4) "Converted Voice" means any voice output converted by the Product.
- (5) "CRIMSON's Characters" are the Characters to which CRIMSON owns the copyright.
- (6) "Other Company's Characters" are the Characters whose copyright belongs to companies or individuals other than CRIMSON.

Section 2. Relationship with the Copyright Act and other applicable laws

- (1) The Characters shall be protected by the Copyright Act of Japan and other applicable laws.
- (2) CRIMSON owns the copyright for the modified works of the CRIMSON's Characters.
- (3) Based on Article 28 of the Copyright Act of Japan, with respect to the usage of the Secondary Works of CRIMSON's Characters, CRIMSON owns proprietary rights to the same types of rights held by the authors of the said Secondary Works amongst the rights stipulated in Articles 21 through 27 of the Copyright Act of Japan.

Section 3. License

Subject to the User's compliance with EULA of each Product and this Guidelines, CRIMSON permits individual users (companies are not included) to publish and distribute the secondary works with the Characters' Converted Voice or the CRIMSON's Character's images only for non-commercial use.

The scope of non-commercial use shall be defined in Section 4 of the Guidelines.

Regarding the usage of Other Company's Characters, you should follow the regulations and Guidelines established by the owners.

The Converted Voice of "Masayuki Sakai" Social Media Operation Guidelines

- (e) Selling or Distributing the Secondary Works which use CRIMSON's Characters and the Converted Voice for the purpose of recovering the costs.

Section 5. Requirement for the additional permission

About using the Characters and the Converted Voice in any of the following ways or purposes, it is necessary to make another license agreement separately. In that case, please inquire to "Contact" attached to the bottom of the Guidelines.

- (1) In the case where individuals use the Converted Voice of the Characters for commercial purposes.
- (2) In the case where individuals use the CRIMSON's Characters for commercial purposes.
- (3) In the case where corporations use the Converted Voice of the Characters for commercial and non-commercial purposes.
- (4) In the case where corporations use the CRIMSON's Characters for commercial and non-commercial purposes.

Section 6. Prohibit acts

The following acts are prohibited regarding the usage of the Characters and the Converted Voice.
